STUDENT'S/BUYER'S RIGHT TO CANCEL

Student has the right to cancel the enrollment agreement and obtain some refund of charges paid through attendance at the first day of class (ie. end of day on first Tuesday of class), or the seventh day after signing the Enrollment Agreement, whichever is later. All refund amounts are calculated using the minimum unit of 1 week and are based on recalculated weekly tuition rates or accommodation rates according to the total number of weeks actually studied or used. Stafford House will pay or credit any refund within 45 days from the date of written notice of requested refund. Refunds are always returned to the original payer. All refund calculations will be based on the percentage of your total program completed, inclusive of the initial enrollment and all extensions.

If Stafford House cancels a program after a student's enrolment, all monies paid will be refunded to the fee-payer.

Where applicable, the following fees are considered non-refundable fees, with noted exceptions:

- Registration fee - \$150
- Accommodation Booking Fee - \$100
- Payment Fees such as Bank Transfer Fees or Credit card processing fees
- Courier Fees (refundable prior to sending) - \$60

There will be a charge equivalent to the cost of two week's accommodation fees, if you cancel accommodation, or postpone your arrival date, less than 2 weeks before the start date.
