INCENTIVES FOR EXISTING TEACHERS (POST CONTRACT)

DELTA MODULE ONE COURSE

Suitably qualified Teaching staff completing a minimum of 4 weeks work during summer 2025 may be eligible to apply for free DELTA module 1 course, run by Stafford House International, London. *T&Cs apply.

DELTA T&Cs:

- Places are limited (first apply, first booked)
- Only teachers with a minimum of two year's classroom experience post-CELTA may apply for DELTA
- The course is subject to successful acceptance onto the DELTA Module 1 course, consisting of interview and pre-interview task.
- SHI will cover the cost of the DELTA Module 1 course, with the exception of exam fee (£127.00) which is to be paid by the applicant.
- Dates are subject to availability.
- Applicant must commit to taking the DELTA Module 1 exam, in writing.
